Staff emphasized the need to focus on affordability of operations and maintenance of the facility for both parties. Staff and Board discussed programming, maintenance needs, details of the Intergovernmental Agreement, and expenses and income.

B. Brookens Lease

Director Bartlett noted there is no draft lease agreement at this point, but it should be forthcoming in the next few weeks. Staff and Board discussed future of the Brookens space, UPD rental costs, field rentals/usage/maintenance, communication around timelines, and capital spending on the facility.
