# Call to Order

UPDAC Chair, Laura Hastings, called the meeting to order at 6:31 PM.

### II. Public Comment

# III. Approval of March 22, 2022 UPDAC Meeting Minutes

David Dorman made a motion with a second from Jean Paley to approve the minutes of the March 22, 2022 UPDAC Meeting. A vote was taken, and the motion passed.

# IV. Discussion

## A. Blair Park Tour

During the tour of Blair Park, Executive Director Tim Bartlett provided an overview of the history of the park and its namesake, Joseph C. Blair. The 11-acre site was first acquired in 1944 and developed especially for youth. Joseph Cullen Blair was an important figure in the creation of public parks in Illinois, and helped start the Urbana Park District in 1907. He also spurred the formation of the first state park in Illinois – Fort Massac State Park –and has been called "the Father of the Illinois State Park system."

Superintendent of Planning & Operations Derek Liebert, provided some background on the planning process for the Blair Park improvements, noting that there was a great deal of public input, including from the community's youth. UPDAC also played a significant role during the public input process. He then reviewed the construction schedule and said that the playground is nearly complete, with the challenge course remaining to be finished, along with project clean-up and final seeding. The recent improvements were funded by an Open Space Land and Development (OSLAD) grant.

While the OSLAD included many park features within its scope, the tennis courts were not included. The Urbana Parks Foundation has been fundraising for the renewal of the courts, and has been successful. The bids for the courts are scheduled to be opened soon, with construction expected to begin this summer. Some of the park features include the Sutu Wall, horseshoe pits, water feature, challenge course, playground, and pavilion. UPDAC commented that the water feature could use some landscaping and that the challenge course is exciting. Tim gave an overview of the Blair Park Pavilion, and noted that there is a donor interested in donating toward its rehabilitation.
