Each year, the Urbana Park District Board of Commissioners appoints new Urbana Park District Advisory Committee (UPDAC) members for a three-year term. The current UPDAC membership is 13: 5 members completed their terms, 2 resigned due to moving out of district, and 6 have been appointed so far this summer. The following names are being presented for discussion for appointment, and it is recommended that the applicants listed below be appointed to fill vacancies on the committee:

Call to Order - Welcome New Members and Introductions

Approval of the Minutes of the June 28, 2022 Meeting- At the start of the meeting, only 6 UPDAC members were in attendance. Without a quorum, we were unable to approve meeting minutes until later in the meeting when another member arrived.

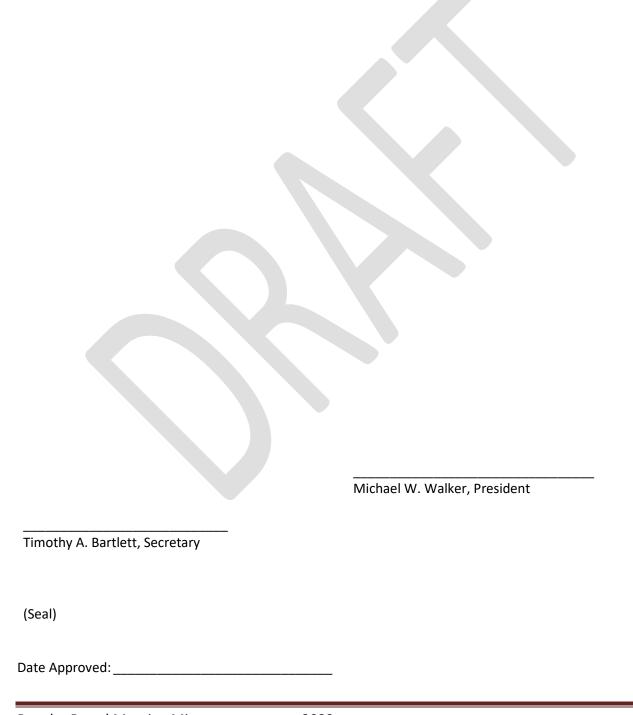

ANTI-VIOLENCE COLLABORATIVE - AVC

Principal Taren Nance, Urbana High School, has formed a new leadership group for the Urbana School District called "Anti-Violence Collaborative". As we understand, this group is a separate 501 (3) C organization formed to help reduce violent behaviors at Urbana schools. The purpose of the group is to work with all community groups and leaders to help bring problem-solving outcomes to current problems regarding violence in the schools and community.

One key aspect of this group is that they are open to alternative ways to problem solving. It was reported that the current methods of education will never be adequate with a certain population of students. Many underserved African American males and females at the middle school and high school level that have experienced significant trauma from early in life will not appropriately follow the advice/direction from "school authorities"—including teachers, aides, and administration. Further, the disciplinary approaches are inadequate to keep students engaged and attending school. Alternative methods are needed to attract and engage with youth and their families. AVC is intended to serve as a group of local leaders that can bring new ideas and resources to the tool box of making our schools work.

There will likely be a need for the UPD to respond to helping by providing more services. For example, it is known that students with ADDH impacts are unable to stay focused for a full day of classes. There may be a need for exercise or relaxation activities to help refocus students that need help staying on task. The UPD could be one of the groups that could help bring recreational aspects into the classroom to help engage with student learning outcomes. Image and appearance is of critical importance to most young people. Finding mentors and leaders that can help project positive mind and body images for youth will be most critical. The UPD has an opportunity to help provide alternative experiences to attract youth and families into attending school on a regular basis.

More information about what AVC is all about and how we can successfully engage with the other leaders will continue to unfold over the next few months. Tim Bartlett and Corky Emberson will be sharing attendance duties with this group. We plan to share the information with staff and to continue working with UPDAC and the Board of Commissioners to make any appropriate changes to our service delivery.

ADMINISTRATION REPORT

URBANA INDOOR AQUATIC CENTER (UIAC)

The UPD staff and board member representative (Nancy Delcomyn) have two preliminary meetings scheduled to help our team prepare for the upcoming meetings with the Urbana School District representatives. To date the UPD has reviewed past performance of the UIAC, identified the number of staff involved with that operation, discussed future capital improvement approaches and discussed ways to help reduce the number of staff working at the UIAC. In addition, staff reviewed the programs that provide and create revenue. Staffing levels were discussed as well, noting that we are not able to fully staff both the UIAC and the Crystal Lake Park Family Aquatic Center (CLPFAC) at the same time due to a reduction of available workers. Increased staff costs have increased our operation at both pools.

In addition, we discussed areas of increased costs to operation including: staffing, utilities, operational costs, capital costs, reduced attendance/memberships and future trends. It is known that there are blocks of time that the facility is open for the "walk up" customer—these timeframes most often do not bring in appropriate levels of revenue. Both evenings and weekend time blocks can often be vacant without swimmers. Alternatively, there is growing use of "rental" time blocks for the facility—renting the entire facility for special uses and activities. Rentals should also be considered as use by other school districts that do not have their own pool. This would be an example of revenue positive use of the facility that helps to reduce the overall cost of operations. Staff will continue working on putting a draft schedule together that could highlight ideal times to operate and times that closure/reduction in hours might help bring cost savings. The UPD team plans to be prepared with knowledge of our current operation and be able to present cost saving options to consider for the next use agreement for the UIAC.

Business Services – Laura Orcutt, Finance Manager

In August, Finance Manager continued working with the audit firm of Sikich LLC on the district annual audit. UPD is awaiting their preliminary audit report for review so that Finance Manager can draft and submit remaining audit items of Management Discussion & Analysis, Transmittal Letter, and the Statistical Schedules of the Comprehensive Annual Financial Report – as required.

Finance Manager also worked with IPARKS by gathering/reviewing materials to renew the annual Property & Liability Insurance Policies due 10/16/2022.

The Business Office staff are settling in to their new roles and duties. Training never really stops and cross training for a more comprehensive knowledge base is being planned. It has been a hectic first half of the calendar year and I am very proud of the hard work the Business Office Staff have been putting in!

UPF will be looking back over the activity of the last year, along with looking ahead toward the exciting developments in Meadowbrook Park: the Wandell Sculpture Garden 25th Anniversary Celebration, and the new playground design.

The Urbana Park District Advisory Committee (UPDAC) met on August 28 for the annual kick-off meeting at the Meadowbrook Interpretive Center. Staff presented a review of UPDAC activities over the past year along with a look forward to upcoming work. It was a great opportunity to get to know our new members a bit better. We also received three new UPDAC applications in the month of August, with appointments slated for the September Regular Board Meeting. Our new members bring new and interesting perspectives, and I am excited to see where the next year takes UPDAC.

Aside from UPF and UPDAC activities, I attended an IU Fund Raising School course, Principles and Techniques of Fundraising, in Indianapolis. This is the first course toward achieving a Certificate in Fundraising Management. The course was high quality. I enjoyed networking with other fundraising professionals in various fields, and I came away with many actionable steps toward improving our fundraising management processes. I am looking forward to taking the rest of the series!

Deer Fatalities

Over the past week, IDNR Biologists have found seven dead deer at Meadowbrook Park and Yankee Ridge. Several have been taken for sampling at the University of Illinois Wildlife Vet-Med clinic. IDNR suspects it is Epizootic Hemorrhagic Disease (EHD) and already has had a positive test result for EHD in Vermillion County. EHD typically occurs in the late summer and early fall, especially during dry conditions, when small stagnant pools facilitate transmission between whitetail deer and the gnats/midges that carry the disease. All of the deer were found within 100ft of water at Meadowbrook Park. Staff found additional deer at the Perkins Rd site and facilitated access to that site for IDNR's evaluation as well. EHD only affects ruminants, so humans and most domestic pets are not susceptible. There are no recommended treatments, and the disease subsides when cold conditions reduce the midge population.

Auxiliary IT Needs

Staff continue to work with MCS, the district's supplemental IT service provider to the City of Urbana. The City of Urbana oversees the districts network and networked desktop pcs, servers, and backup storage. MCS supports Wi-Fi, security cameras, AV, electronic entrances, etc. MCS is working on reviewing and making recommendations for the new Health and Wellness Center as well as updates to the district's security cameras.

Facilities Supervisor Shane Newell

Nature Center Doors

Commercial Builders replaced two exterior doors in the basement of the Nature Center. The original doors were rusted along the bottom of the doors and door frames which made opening and closing difficult. The original panic devises and locks were re-used. Facility Maintenance staff will paint the doors/frames and repair any damaged drywall in the interior surrounding the frames. Total cost including material and labor was \$8,100.

Water Line Repair

A park patron reported an underground water leak in the Organic Gardens at Meadowbrook Park recently. Facility Maintenance staff shut off the water supply and waited a couple of days prior to excavation so the soil could dry. Once the water line was exposed, A&R Mechanical arrived to complete the repair.

Grounds Supervisor Rich McMahon

Grounds Notes

The arbor crew recently removed all the branches off a large, dead White Oak on the north side of Nature Playscape. The trunk was left standing for a future woodcarving project. This was a challenging site to get the lift truck to, as it's at the top of slope that runs down to Country Club Road, tucked between the slope and Nature Playscape. We had to wait until summer camps were done, so the area wouldn't be filled with kids, and also had to limb up a few trees in the path that the lift truck took up the slope, from the road.

A drainage project was completed by Thornton Rave Construction in the outfield of the east ball diamond at Ambucs. The right field area has had issues with holding water through the years, which has made a good part of the outfield unusable during significantly wet times of the year. It hasn't caused a large amount of disruption to games being played out there, because the Tom Jones Challenger League has been the biggest user of the field for the last several years. Most of their action takes place on the infield, so games were able to go on, even when the outfield was wet. With us eventually losing Prairie North & South, and the likelihood that Ambucs will see increased action from other users, we felt it was important to get this problem fixed permanently.

We were able to save a Blackgum from the area where our new learning pavilion is being built, south of Nature Playscape. This tree is approximately 35' tall and has a DBH of 10", but was located in the footprint of the new building. Relocating it about 100 yards south, to a spot just east of the pool bath house, required the use of the Big John tree spade, owned by Sharp Nursery and Tree Transplanting. To help reduce transplant shock, several things were done. First, the canopy was sprayed with Transfilm, an anti-transpirant. Second, a soil drench of the root ball was performed with a Mycoorhizza solution. The tree was mulched all the way out to the dripline. At the advice of Sharp, a cabling system was installed, with ground anchors and ratchet straps. The tree has been watered thoroughly to this point, and will continue to be on an elevated watering schedule as we go forward.

Sculptures

We have worked on a lot of things for our sculpture program recently. We rehabbed a folk art post (images carved out of post SE of Prairie Play) with new paint and extending the post with new wood. We installed one of our portable concrete pads for a Janet Austin sculpture in Timpone Tree Grove, dug a hole and filled with compacted rock for a large/heavy Harry Gordon piece that is coming soon, and ordered signage for the new sculptures that are arriving. We are storing a new piece at Hickory St. storage site until the concrete pad is ready for sculpture installation. This piece is very cool; it is an American Bison with her calf all made out of steel rebar. It looks great and will be a fine addition!

Playgrounds

We have replaced several rubber wear mats in several different playground due to being extremely worn. Also installed the ones for our new playground at Blair. Wear mats are 2 ½ in. thick recycled rubber mats that go under swings and at the end of slides to help with keeping the safety surfacing from getting displaced in these areas. They also help with keeping the playground accessible.

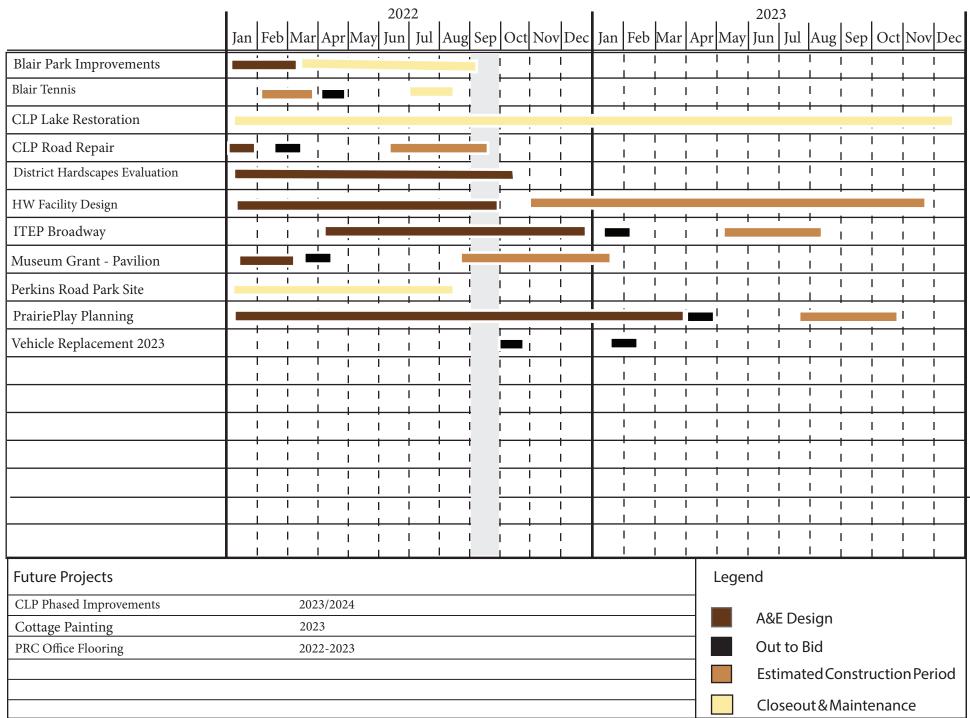
UIAC

The Urbana Indoor Aquatic Center was re-opened from its summer closure. The competition pool heater had its heat exchanger and burner tubes cleaned, and one of its fans replaced. After several attempts by Spear Corp. to repair the activity pool UV system, the unit was officially declared unrepairable and remains out of service. Efforts to procure replacements for other aging equipment such as the activity pool filter pump and sanitary sewer lift station pumps continued. Aquatics maintenance staff toured the Sholem Aquatic Center to network with new Champaign Park District aquatics professionals and discuss pool maintenance topics.

CLPFAC

The Crystal Lake Park Family Aquatic Center concluded its decennial season and is being prepared for winterization. Replacement water level sensors are scheduled for installation by Spear Corp. on September 7th. Staff began painting doors and handrails.

Public Information and Marketing

Public Information Manager, Mark Schultz – Marketing partnered with the Anita Purves Nature Center to promote and advertise the inaugural Climate Action Week in August. The week got plenty of media attention, including WCIA-TV interviewing Savannah Donovan and Savannah appearing on the Stevie Jay morning radio show.

We promoted several events starting in August and running through September – including Folk 'n Roots Fridays, Jazz Walk, Teen Hangout Zone and S'mores Social and Stroll.

Looking ahead, marketing will heavily promote Jazz Walk, fall athletic events, community events, Welcoming Week, Take a Child Outside Week, and begin preliminary promotion for Turkey Trot.

Aquatics

Aquatics Manager, Leslie Radice – The Aquatics Staff is focusing on finishing off the season as strong as possible. There have been staffing issues/shortages within the last few weeks. Many students have gone back to school or are in sports and are in return, not working. The full time staff has worked as hard as possible to keep the doors to the facility open. So far, there have only been 4 evening closures. This is the anticipated final number of inoperable days due to staffing shortages as well.

Staff is getting prepared to transition to indoor aquatics as well. Information is going out to members and the public about the upcoming opening date, along with information being posted at the Urbana Indoor Aquatic Center. There will be a new lifeguard class conducted soon as well to help with staffing numbers and availabilities.

Community

Community Program Manager, Janet Soesbe – This year's Crystal Lake Park Art Fair was once again held next to Friendship Grove at the Anita Purves Nature Center. We had approximately 2,000 shoppers come to visit our 41 artists that came from the C-U area as well as other Illinois locations plus Indiana and Missouri. The day was extremely hot and humid, so the amount of community support was amazing. As with all of our special events, the Art Fair could not be possible without those district staffers who work so hard at different stations throughout the day. In our artists' surveys, one stated, "The best thing was that, in spite of the horrible heat, everyone was upbeat and suffering together and I can't believe I'm going to say it was actually fun (I hate extreme heat and humidity). Also the entire staff of the event was exceptional; making multiple stops to deliver ice and water and ask if we needed booth sitters and many available for help with set up and tear down if needed".

Community Program Coordinator, Matthew Lewis – Both the Program Coordinator and Community Program Assistant has been working on getting the PRC meeting rooms cleaned up from the summer camp and getting the supply closets organized for the next season of SPLASH. The Program Coordinator has also been working with school site Coordinators to setup a schedule for this school year's SPLASH program and working with SPLASH Leaders/Supervisors to make sure we have our classes and activities planned out. Both the Coordinator and Assistant have also been conducting interviews and getting staff hired for SPLASH as well. For staff we already have hired or are returning from last spring, we are working on creating their schedules and getting them inputted into NOVAtime.

Both the Community Program Coordinator and Assistant have also been coming up with plans to prepare for our upcoming new programs we will be offering in the fall. Additionally, coming up with new ideas and programs we could offer in the winter and spring next year and thinking of ways we can make changes to the Summer Arts Camp to better enhance the experience for the kids and staff alike. Some of these changes include altering the themes slightly and coming up with a way to better train staff so they are more prepared for the summer.

In addition to the new programs, the Community Program Coordinator and Assistant have been planning the upcoming School's Out Days and Holiday Camp and looking at options for field trips. Lastly, the Community Program Coordinator has been coming up with a timeline and plan for our upcoming Read Across America that is set to take place on Saturday, March 4th, 2023. We are working on an agenda and plan to have our first initial meeting within the next month.

Recreation Office Manager, Heather Britsky – The Recreation Office Manager spent a majority of August emptying out the storage rooms to assess and organize all current supplies. Along with the Community Program Coordinator and Community Program Assistant, every item was evaluated on its continued use. Since Covid paused multiple programs for over two years, many items had expired and needed to be tossed. Others had been well-used and were no longer in decent condition. What was left was sorted and either put aside for auction, donated, or organized and categorized for reentry into the storage rooms.

- The Phillips Recreation Center had 0 billable rentals with 0 people.

Environmental

Environmental Program Manager, Savannah Donovan – This month the manager coordinated the Urbana Park District's first annual Climate Action Week, August 22-28. The week was full of engaging opportunities to learn about climate change causes and effects, local impacts, and how to be part of the solution. A total of 579 people participated in Climate Action Week programs and events with the Urbana Park District.

This was an "open road" event; the park road was closed to vehicles to allow participants to safely bike, roll and stroll. Anyone who biked, walked, or rode the MTD to the event was able to enter the "Eco-Transit Raffle" for one of seven prize bags. The manager received lots of excellent feedback about the entire week of programming, and she is looking forward to doing more with this annual event in years to come.

Environmental Education Coordinator, Chelsea Prahl – This month the coordinator has been managing a large, facility-wide project to organize and utilize all natural history items, books, reference guides, field equipment and program supplies at the Anita Purves Nature Center. Project objectives and tasks include:

- 1. Dismantling unused loan kits and program boxes; evaluating, organizing and restocking program supplies.
- 2. Inventorying and cataloging natural history items while creating a public loan inventory.
- 3. Discarding any contaminated, broken or unwanted items.
- 4. Cataloging all books in online database "Library Thing".
- 5. Updating the associated webpages to reflect these changes.

The coordinator also met with the Graphics and Marketing Coordinator to create digital graphics and flyers to inform local educators of the school standards-based environmental program opportunities available for the 2022-23 school year. This involved updating the website to reflect this as well.

Environmental Public Program Coordinator, David Subers – The coordinator spent much of this month wrapping up camp programs. This included building cleanup, managing supplies and lost and found, collecting camp survey responses, completing exit interviews, and termination paperwork for 10+ part-time staff members. Overall, Nature Day Camp and Wild Child Survival Camp were resounding successes. We garnered plenty of positive feedback from adults, as well as some areas we can work to improve for next year. One of our main difficulties this season was with consistent staffing, particularly in working with Champaign-Urbana Special Recreation (CUSR) to provide accommodations for campers with specific

needs who often require one-to-one support. To help remedy this challenge, the coordinator will attend upcoming meetings with CUSR to discuss the best way to move forward.

Environmental Office Manager, Nicole Hilberg— The office manager spent time this month working with Consolidated Communications to personalize all facility phone lines' Caller Identifications. Previously, the default Caller ID from all UPD outgoing lines was "Voice Axis Champaign." Feedback from both internal and external customers showed they thought it was a SPAM call and therefore did not answer. Now six of the eight outgoing facility phone numbers show as "Urbana Parks" while the Lake House is simply "Lake House" and the Anita Purves Nature Center is "AP Nature Cntr."

Environmental Programs and Anita Purves Nature Center Rentals:

- The Nature Center hosted 26 onsite programs that served 1,178 people.
- The Nature Center was rented 0 times. The total number of people using the Center for rentals and meetings was 0.
- The Nature Center welcomed 1,982 people visiting or participating in programs at the Center.
- The Nature Center staff coordinated and conducted 3 offsite programs for 247 people this month.

Outreach and Wellness

Outreach & Wellness Manager, Elsie Hedgspeth — During August, the Outreach & Wellness department worked with administration and the Urbana Park District planning team to begin fitness equipment selection and interior finishes for the new Health & Wellness Facility. The group conducted two site visits to Stephens Family YMCA in Champaign and Elite Sport & Fitness in Gibson City. Through the site visits, the group was able to discuss equipment brand preferences, the maintenance needs of various types of equipment, customer service experiences with different equipment companies, and the benefits of equipment purchasing versus leasing. The group also discussed sound amplification options for each of the spaces at the new facility as well as music streaming options best suited for fitness facilities. The department worked with the architecture and interior design teams at Farnsworth to provide feedback on interior finishes and furniture selection for the new facility as well.

Outreach & Wellness Coordinator, Ashley Dennis – During the month of August, the coordinator has been planning for the January – April guide. The department is looking to return to offering a Pilates class during this season and is trying to work with existing classes and the instructor's availability to find a consistent time for the class.

- A new communications initiative that tells the public they belong.

PLANNING & OPERATIONS DEPARTMENT

Procurement and Employment

- Staff worked with a MWBE contractor to install two concrete pads and repair two broken sections of pathway at Meadowbrook Park. The work was all completed on time and the contractor is continuing to work with the park district to address a few punch list items.
- Staff also sought a proposal for painting of the Leal Park cottage from an MWBE contractor for work planned next year.

YOU BELONG HERE REPORT

RECREATION DEPARTMENT

Community Programs Division

Back-to-School Fairs – The Recreation Office Manager was invited to attend Back-to-School fairs for both Dr. Williams and King Elementary. The Community Program Coordinator joined her at these events, where they spoke with multiple families about upcoming programs and free events. They were even able to do on-site registration for four families. The office manager also made a connection with Crisis Nursey, with plans to share resources with each other to provide to the public.

Environmental Programs Division

FRESH Teen Hangout Zone – The Environmental Education Coordinator worked alongside the Outreach & Wellness and Community Programs Coordinators to provide a FRESH Teen Hangout Zone on August 5th from 3-6pm at Blair Park. FRESH Teen Hangout Zones provides a safe and welcoming place for teens to enjoy reading, drawing, crafting, playing games or just socializing at the park. Teens can come and go during program hours, or stay the whole time. Coordinators provide dinner and refreshments as well as activities such as Nintendo Switch games, board games, art supplies, Cricut crafting and more. Thirty-eight (38) teens came to the FRESH Teen Hangout Zone on August 5.

Health and Wellness Division

CommYOUnity — During August, the Outreach & Wellness staff worked with the Champaign County Community Coalition to host the CommYOUnity Event at the Brookens Athletics Fields. This event was originally intended to be held in mid-July, but was rescheduled for August due to inclement weather. The Champaign County Community Coalition had approached the Outreach & Wellness department in March to assist in planning and implementing an event for the Lierman Neighborhood due to the rise in violence in the area between 2021-2022. The event was attended by over 200 people. At the event, the Urbana Park District provided food and drinks, book bags with school supplies, scholarships, arts and crafts, sports, and entertainment through Urvana Mobile Recreation Unit. The event also featured a DJ and a bounce house. Many of the attendees for the event were residents from the immediate Lierman Neighborhood. The Outreach & Wellness department invited staff from Champaign-Urbana Special Recreation to attend and provide an activity for participants as well.

YOU BELONG HERE REPORT

Urvana – Urvana's first event during the month of August, was the Teens Only Fresh Hangout Zone on August 5th. This was the last scheduled Teen Hangout Zone at Blair Park before the school started back in session for Urbana middle and high schools. There were about 30 teens that dropped by to grab pizza, play switch games, make a bracelet, or play RC cars.

That following Saturday, August 6th, Urvana provided a kids zone for the Crystal Lake Part Art Fair. The Community Programs Manager, estimated around 2000 attendees came to the Art Fair that day. Urvana gave any kids at the event with yard games to play, a sensory area to color and fidget and crafts for recycled jewelry and DIY tshirt bags. Anyone that stopped by could also add to the community art piece that was also recycled materials.

On August 10th Urvana helped to program a Steer Place Ice Cream Social at the Steer Place Apartments in Urbana. UPD staff provided music trivia at the event, cut and serve cake for the residents, and provide a photo opportunity with our photo booth. Around 30 residents came to enjoy the festivities from 2-4pm.

August 11th was the last Play Day in the Park for Summer 2022 at Crestview Park. Almost 200 people came out to enjoy music, popcorn and lemonade, play Urvana's games, get their face painted, have a caricature drawn and just hang out.

On August 14th, Urvana was invited to a Back to School event at the Cunningham Township in Urbana. At least 200 people stopped by Urvana's area of setup to play games, make bubble wands, and talk about UPD programs. 6 scholarships were provided to families at the event.

Urvana also provided a kids area for the Climate Action Week Event on Saturday, August 27th. Urvana had UPD information, our recycled jewelry crafts, and a sensory area for kids to explore nature with magnifying glasses and bug boxes.

The last event of the month for Urvana was on August 30th at AMBUCS park for the annual Dual Language Back-to-School Picnic with USD #116. All of the yard games, crafts, and games that Urvana set out were all being used the majority of the event from 4:30-6:30pm. Around 300-350 people came out to AMBUCS.

Re: Action to Award Weaver Park and Prairie Park Master Planning Services

I. Statement of Situation

Beginning in 2016, Urbana Park District staff began a planning process to review outdoor athletics and wellness opportunities in the district and their accompanying facilities. The main goals were to address trends in participation, review the condition of fields, assess new opportunities, and make overall recommendations for improvements moving forward. Staff conducted visits to outdoor athletics complexes, including Bloomington-Normal, to learn more about what facilities exist and how they are being programmed.

Then, with a new possibility of an indoor athletics and wellness opportunity, the team postponed the outdoor planning process and began visiting indoor recreation facilities and planning for what would eventually be the Health & Wellness Facility. This exciting process took a large amount of staff time and energy to get to where we are now, breaking ground in the next few months.

The addition of the Health & Wellness Facility at Prairie Park offers tremendous recreation opportunities for the surrounding neighborhoods and the City and region as a whole. It does, however, remove two currently utilized softball diamonds which are the only two directly adjacent to each other in the district. They are a popular rental amenity because of their affordability, and are also the home of park district programs such as kickball. The removal of these two diamonds, the previous outdoor athletics and wellness work district-wide, and the need for an updated master plan for the Prairie-Weaver complex necessitates a significant planning process that helps prioritize future improvements as the district seeks to update the Master Plans for Weaver and Prairie Parks.

The 2005 Weaver Park Master Plan calls for two adjacent softball diamonds and one adjacent baseball diamond to the south. The plan additionally calls for nine soccer fields in the center of the park and a series of trails that connect the athletic fields with the natural areas to the north. The Health and Wellness Facility planning included some level of master planning in the areas of Prairie Park that are adjacent to the future facility but did not cover the entirety of the park. With this effort, the combined park areas will receive updated planning reflective of current athletic and community needs while assessing and accounting for athletic field offerings elsewhere throughout the district and the adjacent leased Brookens Center's fields.

II. Statement of work

The services to be performed by Farnsworth Group, Inc. include:

- Needs Assessment & Potential Programming: demographic analysis, needs assessment of all UPD outdoor facilities, develop an initial community survey.
- Preliminary Site Analysis: assessment of Weaver Park topography, site access, utilities, etc.
- **Staff Workshop #1:** Farnsworth and UPD staff will participate in an in-person working session to review survey results and begin preliminary planning.
- Focus Group Facilitation: focus groups will be facilitated with one focusing on outdoor fields and the other on general outdoor needs such as trails, pickleball, skate park, etc.
- **Staff Workshop #2:** review of focus group feedback and how it will be incorporated into the next phase of planning.
- **Alternative Site Plans:** initial site plans will be created for the Prairie-Weaver area and a virtual community meeting will be facilitated and second survey created.
- **Staff Workshop #3:** review results of community input and assess needs at other UPD parks with the future of Prairie-Weaver becomes more detailed.
- Vision Book: present to Board of Commissioners, host a final community meeting, and then incorporate these comments into the final Vision Book complete with final master plan for Prairie-Weaver, site diagrams, enlargement of key areas, precedent imagery, and conceptual cost estimates.

III. Schedule

The board action recommended is to award services and begin work in October 2022. The current schedule contains:

Following up on the various conversations we have had with you and your team, attached is our proposal to develop a master plan for Prairie Park and Weaver Park. In addition to developing the master plan, it also includes the robust public engagement Kara requested, alternative site plans for county owned land around Brookens Administrative Center, and suggestions for where ballfields and other recreational amenities could be located outside of Weaver / Prairie Park that are desired by the public. We view this as a collaborative effort between Farnsworth Group, UPD, and the residents of Urbana, and look forward to assisting on this important civic effort.

PROJECT OVERVIEW /

Our understanding of the project is based on the following communications:

- Phone call on 6/15/22, between Farnsworth Group and UPD
- Follow up phone call on 6/20/22 between Debbi La Rue and Kara Dudek-Mizel
- Emails on 7/12/22 and 7/13/22 between Farnsworth Group and UPD
- Follow up phone call on 8/12/22 between Farnsworth Group and UPD

The project is intended to prepare a cohesive master plan for both Prairie Park and Weaver Park. The planning process will include stakeholder engagement, along with multiple working sessions with Urbana Park District (UPD) staff. The final deliverable will be an 8.5° x 11° or 11° x 17° 'Vision Book' that will be suitable for fundraising, grant submittals, public meetings, etc.

PROJECT LIMITS /

The project study area is shaded in yellow and green on the graphic to the right. Prairie Park is 20.0 acres, while Weaver Park is 59.25 acres.

In addition, the following areas are included in the project limits:

- County-owned property around Brookens Administrative Center that UPD might acquire.
- As described in Task 1.1, all UPD facilities will be studied in a high-level needs assessment intended to inform design decisions for Prairie Park & Weaver Park.

SCOPE OF WORK

Reference Conditions: Farnsworth Group, Inc. will hereinafter be referred to as "Farnsworth Group," the above referenced Client will be referred to as "Client," and the above referenced Project will hereinafter be referred to either as Project or by abbreviation as above set forth. Farnsworth Group is defined as including Farnsworth Group, Inc. and its subsidiaries, affiliates, contractors, subconsultants and agents, including their respective officers, directors, employees, successors and assigns.

Entire Agreement: These General Conditions and the signed document to which they are attached constitute the entire Agreement between Client and Farnsworth Group, and are referred to hereinafter collectively as the "Agreement". The Agreement supersedes all prior communications, understandings and agreements, whether written or oral. Both parties have participated fully in the preparation and revision of the Agreement, and each party and its counsel have reviewed the final document. Any rule of contract construction regarding ambiguities being construed against the drafting party shall not apply in the interpreting of the Agreement, including any Section Headings or Captions.

Precedence: The Agreement shall take precedence over any inconsistent or contradictory provisions contained in any proposal, contract, purchase order, requisition, notice to proceed, or like document regarding Farnsworth Group's services.

Fee Schedule: Where lump sum fees have been agreed to between the parties, they shall be so designated in the signed document attached hereto and by reference made a part hereof. Where fees are based upon hourly charges for services and costs incurred by Farnsworth Group, they shall be based upon the hourly fee schedule annually adopted by Farnsworth Group, as more fully set forth in a Schedule of Charges attached hereto and by reference made a part hereof. Such fees in the initial year of the Agreement shall be those represented by said Schedule of Charges, and these fees will annually change at the beginning of each calendar year after the date of the Agreement.

Invoices: Charges for services will be billed at least as frequently as monthly, and at the completion of Project. Client shall compensate Farnsworth Group for any sales or value added taxes which apply to the services rendered under the Agreement or any amendment thereto. Client shall reimburse Farnsworth Group for the amount of such taxes in addition to the compensation due for services. Payment of invoices shall not be subject to any discounts or set-offs by Client unless agreed to in writing by Farnsworth Group. Invoices are delinquent if payment has not been received within thirty (30) days from date of invoice. Should a past due amount exceed sixty (60) days, Farnsworth Group shall have the right to suspend all Services, without liability of any kind to Client, until full payment is received. All time spent and expenses incurred (including attorney's fees) in connection with collection of any delinquent amount will be paid by Client to Farnsworth Group per Farnsworth Group's then current Schedule of Charges.

Confidentiality: Each party shall retain as confidential all information and data furnished to it by the other party which are designated in writing by such other party as confidential at the time of transmission and are obtained or acquired by the receiving party in connection with the Agreement, and said party shall not reveal

such information to any third party. However, nothing herein is meant to preclude either disclosing and/or otherwise using information (i) when the information is actually known to the receiving party before being obtained or derived from the transmitting party; or (ii) when the information is generally available to the public without the receiving party's fault at any time before or after it is acquired from the transmitting party; or (iii) where the information is obtained or acquired in good faith at any time by the receiving party from a third party who has the same in good faith and who is not under any obligation to the transmitting party in respect thereof; or (iv) is required by law or court order to be disclosed.

Modification to the Agreement: Client or Farnsworth Group may, from time to time, request modifications or changes in the scope of services to be performed hereunder. Such changes, including any increase or decrease in the amount of Farnsworth Group's compensation, to which Client and Farnsworth Group mutually agree shall be incorporated in the Agreement by a written amendment to the Agreement.

Compliance with Law: In the performance of services to be provided hereunder, Farnsworth Group and Client agree to comply with applicable federal, state, and local laws and ordinances and lawful order, rules, and regulations of any constituted authority.

Force Majeure: Obligations of either party under the Agreement, other than payment obligations, shall be suspended, and such party shall not be liable for damages or other remedies while such party is prevented from complying herewith, in whole or in part, due to contingencies beyond its reasonable control, including, but not limited to strikes, riots, war, fire, acts of God, injunction, compliance with any law, regulation, or order, whether valid or invalid, of the United States of America or any other governmental body or any instrumentality thereof, whether now existing or hereafter created, inability to secure materials or obtain necessary permits, provided, however, the party so prevented from complying with its obligations hereunder shall promptly notify the other party thereof.

Standard of Care: Services performed by Farnsworth Group under the Agreement will be conducted in a manner consistent with that level of care and skill ordinarily exercised by members of the profession currently practicing under similar conditions. No other representation expressed or implied, and no warranty or guarantee, is included or intended in the Agreement, or in any report, opinion, document, or otherwise.

Assignment: Client shall not transfer or assign any rights under or interest in the Agreement, without the written consent of Farnsworth Group.

Dispute Resolution: In an effort to resolve any conflicts that arise during the performance of professional services for the Project or following completion of the Project, Client and Farnsworth Group agree that all disputes shall first be negotiated between senior officers of Client and Farnsworth Group for up to thirty (30) days before being submitted to mediation. In the event negotiation and mediation are not successful, either Client or Farnsworth Group may seek a resolution in any state or federal court that has the required jurisdiction within 180 days of the conclusion of mediation.

Timeliness of Performance: Farnsworth Group will begin work under the Agreement upon receipt of a fully executed copy of the Agreement. Client and Farnsworth Group are aware that many factors outside Farnsworth Group's control

may affect Farnsworth Group's ability to complete the services to be provided under the Agreement. Farnsworth Group will perform these services with reasonable diligence and expediency consistent with sound professional practices.

Suspension: Client or Farnsworth Group may suspend all or a portion of the work under the Agreement by notifying the other party in writing if unforeseen circumstances beyond control of Client or Farnsworth Group make normal progress of the work impossible. Farnsworth Group may suspend work in the event Client does not pay invoices when due, and Farnsworth Group shall have no liability whatsoever to Client, and Client agrees to make no claim for any delay or damage as a result of such suspension. The time for completion of the work shall be extended by the number of days work is suspended. If the period of suspension exceeds ninety (90) days, Farnsworth Group shall be entitled to an equitable adjustment in compensation for start-up, accounting and management expenses.

Termination: If either party defaults in performing any of the terms or provisions of the Agreement, and continues in default for a period of fifteen (15) days after written notice thereof, the party not in default shall have the right to immediately terminate the Agreement. The non-defaulting party shall be entitled to all remedies under Illinois law at the time of breach, including, without limitation, the right to recover as an element of its damages, reasonable attorney's fees and court costs.

Consequential Damages: Notwithstanding any other provision of the Agreement, and to the fullest extent permitted by law, neither Client nor Farnsworth Group, their respective officers, directors, partners, employees, contractors or subconsultants shall be liable to the other or shall make any claim for incidental, indirect, or consequential damages arising out of or connected in any way to the Project or the Agreement. This mutual waiver of consequential damages shall include, but not be limited to, loss of use, loss of profit, loss of business, loss of income, loss of reputation and any other consequential damages that either party may have incurred from any cause of action including negligence, strict liability, breach of contract and breach of strict and implied warranty. Both Client and Farnsworth Group shall require similar waivers of consequential damages protecting all the entities or persons named herein in all contracts and subcontracts with others involved in Project.

Personal Liability: It is intended by the parties to the Agreement that Farnsworth Group's services in connection with the Project shall not subject Farnsworth Group's individual employees, officers or directors to any personal legal exposure for the risks associated with this Project. Therefore, and notwithstanding anything to the contrary contained herein, Client agrees that as Client's sole and exclusive remedy, any claim, demand, or suit shall be directed and/or asserted only against "Farnsworth Group, Inc., an Illinois corporation," and not against any of Farnsworth Group's individual employees, officers or directors.

They are not intended or represented to be suitable for reuse by Client or others on extensions of the Project or on any other project. Any reuse without specific written verification or adaptation by Farnsworth Group will be at Client's sole risk, and without liability to Farnsworth Group, and Client shall indemnify and hold harmless Farnsworth Group or any subconsultant from all claims, damages, losses and expenses including court costs and attorney's fees arising out of or resulting therefrom. Any such verification or adaptation will entitle Farnsworth Group to further compensation at rates to be agreed upon by Client and Farnsworth Group.

Subcontracting: Farnsworth Group shall have the right to subcontract any part of the services and duties hereunder without the consent of Client.

Certificates of insurance shall be provided to Client upon request in writing. Within the limits and conditions of such insurance, Farnsworth Group agrees to indemnify and hold Client harmless from loss, damage or liability arising from errors or omissions by Farnsworth Group that exceed the industry standard of care for the services provided. Farnsworth Group shall not be responsible for any loss, damage or liability beyond the amounts, limits and conditions of such insurance. Farnsworth Group shall not be responsible for any loss, damage or liability arising from any act, error or omission by Client, its agents, staff, other consultants, independent contractors, third parties or others working on the Project over which Farnsworth Group has no supervision or control. Notwithstanding the foregoing agreement to indemnify and hold harmless, the parties agree that Farnsworth Group has no duty to defend Client from and against any claims, causes of action or proceedings of any kind.

Additional Limitation: In recognition of the relative risks and benefits of the Project to both Client and Farnsworth Group, the risks have been allocated such that Client agrees that for the compensation herein provided, Farnsworth Group cannot expose itself to damages disproportionate to the nature and scope of Farnsworth Group's services or the compensation payable to it hereunder. Therefore, to the maximum extent permitted by law, Client agrees that the liability of Farnsworth Group to Client for any and all causes of action, including, without limitation, contribution, asserted by Client and arising out of or related to the negligent acts, errors or omissions of Farnsworth Group in performing professional services shall be limited to fifty thousand dollars (\$50,000) or the total fees paid to Farnsworth Group by Client under the Agreement, whichever is greater ("Limitation"). Client hereby waives and releases (i) all present and future claims against Farnsworth Group, other than those described in the previous sentence, and (ii) any liability of Farnsworth Group in excess of the Limitation. In consideration of the promises contained herein and for other separate, valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Client acknowledges and agrees that (i) but for the Limitation, Farnsworth Group would not have performed the services, (ii) Client has had the opportunity to negotiate the terms of the Limitation as part of an "arms-length" transaction, (iii) the Limitation amount may be less than the amount of professional liability insurance required of Farnsworth Group under the Agreement, (iv) the Limitation is merely a limitation of, and not an exculpation from. Farnsworth Group's liability and does not in any way obligate Client to defend, indemnify or hold harmless Farnsworth Group, (v) the Limitation is an agreed remedy, and (vi) the Limitation amount is neither nominal nor a disincentive to Farnsworth Group performing the services in accordance with the Standard of Care.

Opinions of Cost: Farnsworth Group's opinions of probable Project cost or construction cost for the Project will be based solely upon its own experience with construction. Since Farnsworth Group has no control over the cost of labor, materials or equipment, or over a contractor's method of determining prices, or over competitive bidding or market conditions, Farnsworth Group cannot and does not guarantee that proposals, bids, or the construction cost will not vary from its opinions of probable cost. If Client wishes greater assurance as to the construction

cost, Client should employ an independent cost estimator.

Subpoenas: Client is responsible, after notification, for payment of time charges and expenses resulting from the required response by Farnsworth Group and/or any subconsultant to subpoenas issued by any party other than Farnsworth Group and/or any subconsultant in conjunction with the services performed under the Agreement. Charges are based on fee schedules in effect at the time the subpoena is served.

Right of Entry: Client shall provide for Farnsworth Group's and/or any subconsultant's right to enter property owned by Client and/or others in order for Farnsworth Group and/or any subconsultant to fulfill the scope of services for this Project. Client understands that use of exploration equipment may unavoidably cause some damage, the correction of which is not part of the Agreement unless explicitly so provided.

Recognition of Risk: Client acknowledges and accepts the risk that: (1) data on site conditions such as geological, geotechnical, ground water and other substances and materials, can vary from those encountered at the times and locations where such data were obtained, and that this limitation on the available data can cause uncertainty with respect to the interpretation of conditions at Client's site; and (2) although necessary to perform the Agreement, commonly used exploration methods (e.g., drilling, borings or trench excavating) involve an inherent risk of contamination of previously uncontaminated soils and waters. Farnsworth Group's and/or any subconsultant's application of its present judgment will be subject to factors outlined in (1) and (2) above. Client waives any claim against Farnsworth Group and/or any subconsultant, and agrees to indemnify and hold Farnsworth Group and/or any subconsultant harmless from any claim or liability for injury or loss which may arise as a result of alleged contamination caused by any site exploration. Client further agrees to compensate Farnsworth Group and/or any subconsultant for any time spent or expenses incurred by Farnsworth Group and/or any subconsultant in defense of any such claim, in accordance with Farnsworth Group's and/or any subconsultant's prevailing fee schedule and expense reimbursement policy.

Authority and Responsibility: Client agrees that Farnsworth Group and any subconsultant shall not guarantee the work of any construction contractor or construction subconsultant, shall have no authority to stop work, shall have no supervision or control as to the work or persons doing the work, shall not have charge of the work, shall not be responsible for safety in, on, or about the job site, or have any control of the safety or adequacy of any equipment, building component, scaffolding, supports, forms, or other work aids.

Electronic Files Transfer.

- (a) Farnsworth Group may prepare electronic files which contain machine-readable information or certain information for a project ("Project Files"). Client may request Project Files to facilitate Client's understanding of the project. The Parties recognize that the Project Files are subject to alteration, either intentionally or unintentionally, due to, among other causes, transmission, conversion, media degradation, software error or human error. The Parties further understand that the transfer of Project Files from the system and format used by Farnsworth Group to an alternate system or format cannot be accomplished without the introduction of anomalies and/or errors.
- (b) Upon request, Farnsworth Group will supply Project Files to Client upon the express terms and conditions set forth herein:
- (i) The Project Files may not be used for any purpose not related specifically to the Client's project. Use of these files for development of other projects; additions to the project, or duplication of the project at any location is expressly prohibited.
- (ii) The Project Files are provided for information purposes only and are not intended as an end product. The Project Files may be a work in process, and Farnsworth Group is under no obligation to provide Client with any updated version(s) of the Project Files.
- (iii) Client acknowledges and understands that the Project Files may not reflect all data contained in the contract documents, addenda, or other pertinent contract-related documents. Client acknowledges and understands that the Project Files may contain data which is not included in the contract documents.

- (c) <u>BIM Digital Files</u>. With regard to the transfer of Building Information Model (BIM) digital files, both Parties agree as follows:
- (i) Farnsworth Group will provide only those BIM files created for Client's project. There is no representation the BIM files are comprehensive or comprise a complete model of the building.
- (ii) The level of development of the model will be defined consistent with AIA Document E202-2008, as agreed by the parties. After reviewing and verifying the accuracy of the information contained within Farnsworth Group's BIM files, Client is authorized to develop its own model to a higher level of development for its own uses, but, in doing so, expressly agrees to assume all risks associated therewith.

Statutes of Repose and Limitation: All legal causes of action between the parties to the Agreement shall accrue and any applicable statutes of repose or limitation shall begin to run not later than the date of Substantial Completion. If the act or failure to act complained of occurs after the date of Substantial Completion, then the date of final completion shall be used, but in no event shall any statute of repose of limitation begin to run any later than the date Farnsworth Group's services are completed or terminated.

Severability: If any term or provision of the Agreement is held to be invalid or unenforceable under any applicable statute or rule of law, such holding shall be applied only to the provision so held, and the remainder of the Agreement shall remain in full force and effect.

Waiver: No waiver by either party of any breach, default, or violation of any term, warranty, representation, agreement, covenant, condition, or provision hereof shall constitute a waiver of any subsequent breach, default, or violation of the same or any other term, warranty, representation, agreement, covenant, condition, or provision hereof. All waivers must be in writing.

Survival: Notwithstanding completion or termination of the Agreement for any reason, all rights, duties, obligations of the parties to the Agreement shall survive such completion or termination and remain in full force and effect until fulfilled.

Governing Law: The Agreement shall be governed by and interpreted pursuant to the laws of the State of Illinois.

Utilities: Client shall be responsible for designating the location of all utility lines and subterranean structures within the property line of the Project. Client agrees to waive any claim against Farnsworth Group and/or any subconsultant, and to indemnify and hold harmless from any claim or liability for injury or loss arising from Farnsworth Group and/or any subconsultant or other persons encountering utilities or other man-made objects that were not called to Farnsworth Group's attention or which were not properly located on documents furnished to Farnsworth Group. Client further agrees to compensate Farnsworth Group and/or any subconsultant for any time spent or expenses incurred by Farnsworth Group and/or any subconsultant in defense of any such claim, in accordance with Farnsworth Group's and/or any subconsultant's prevailing fee schedule and expense reimbursement policy.

Samples: All samples of any type (soil, rock, water, manufactured materials, biological, etc.) will be discarded sixty (60) days after submittal of Project deliverables. Upon Client's authorization, samples will be either delivered in accordance with Client's instructions or stored for an agreed charge.

Discovery of Unanticipated Hazardous Substances or Pollutants: Hazardous substances are those so defined by prevailing Federal, State, or Local laws. Pollutants mean any solid, liquid, gaseous, or thermal irritant or contaminant including smoke, vapor, soot, fumes, acids, alkalies, chemicals and waste. Hazardous substances or pollutants may exist at a site where they would not reasonably be expected to be present. Further, Client recognizes that Farnsworth Group and/or any subconsultant has neither responsibility nor liability for the removal, handling, transportation, or disposal of asbestos containing materials, nor will Farnsworth Group and/or any subconsultant act as one who owns or operates an asbestos demolition or renovation activity, as defined in regulations under the Clean Air Act.

Job Site: Client agrees that services performed by Farnsworth Group and/or any subconsultant during construction will be limited to providing observation of the progress of the work and to address questions by Client's representative concerning conformance with the Contract Documents. This activity is not to be interpreted as an inspection service, a construction supervision service, or guaranteeing the construction contractor's or construction subconsultant's performance. Farnsworth Group and/or any subconsultant will not be responsible for construction means, methods, techniques, sequences, or procedures, or for safety precautions and programs. Farnsworth Group and/or any subconsultant will not be responsible for construction contractor's or construction subconsultant's obligation to carry out the work according to the Contract Documents. I. Statement of Situation

The Open Space Lands Acquisition and Development (OSLAD) grant, through the Illinois Department of Natural Resources (IDNR), is open for applications through September 30, 2022. The grant purpose outlines funding assistance for land acquisition and/or development projects for public outdoor recreation purposes. District staff are pursuing the grant for the Meadowbrook Playground. The Meadowbrook Park Inclusive Playground Project includes the playground replacement which has undergone four rounds of community engagement and also encompasses other improvements such as a rehabilitation of the pavilion, shade sails, interpretive signs, concrete game tables, musical instruments, picnic tables, benches, bike racks and repair station, and native plants, trees, and shrubs.

II. Statement of work

As with previous OSLAD projects, IDNR grant administrators recommend a variety of recreational amenities and robust community engagement for the strongest application. The Meadowbrook playground, constructed in 1995, has been well loved and is in need of replacement. Recent community input provides insight into priorities for the playground including seating and shade in addition to accessibility & inclusion, and a large play area for the capacity of visitors that the playground receives. Valuable input was received through nine months of surveys, community meetings, visits to the park, engagement with kids at SPLASH, and more. These four phases of input were combined into a final Masterplan and directly inform the OSLAD grant application.

The grant application includes a wonderful diversity of amenities, which include:

- Accessible & Inclusive Playground
- Pavilion Rehabilitation (roof, concrete, paint, ADA fountain)
- ADA Picnic Tables (2) & Accessible Benches (3)
- Shade Sails
- Concrete Game Board Tables
- Interpretive Sign & Non-verbal Accessibility Sign
- Musical Equipment
- Native Grasses & Flowers
- Native Shrubs (15) & Shade Trees (6)
- Bike Racks (4) and Bike Repair Station (1)
- Concrete Paths & Ramps for Accessibility; Safety Surfacing
- Site Demolition, Preparation, Grading & Drainage
- Design and engineering fees

III. Budget

The OSLAD funding request will be \$550,000. The local match of \$550,000 is from district capital funds which are budgeted for this project.

IV. Recommendation

Staff recommend that the Board approve Resolution 2022-11 for the OSLAD Grant application for the Meadowbrook Park Inclusive Playground Project.
